- 1) Common and particular personal data, so called sensitive data, about you and collected directly from you at the time of your application, will be processed only for the purposes of recruiting personnel to introduce in Fandis S.p.A. staff.
- 2) Processing may be carried out with or without the aid of electronic or automated tools and shall include all operations or group of operations that are necessary for the processing in question, including the communication to the subjects referred to in the next point 4) of this information.
